The Kendall County Forest Preserve recognizes that there are many local horse owners who do not have access to their own indoor arena, yet still would like to ride in poor weather.

The Ellis Equestrian Center will provide public open arena times twice a week. The public may purchase a yearly or daily tag to ride their horse in the indoor arena at those times. We will strive to serve the horse owning public and keep these arena times open to the public as long as safety and liability standards are met.

We also offer the riding facility for rent for group events. Ellis Equestrian center has set aside a week every 5 weeks for 4-H groups, scout groups and other groups wishing to hold horseback riding clinics or groups with other training needs that require an indoor or outdoor arena or to rent part or all of the facility for their needs.

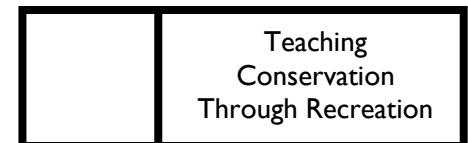

Arena Use Permits

Permit Tags

Any horse owner may purchase a permit bridle tag and participate in the open arena at Ellis Equestrian center. The following requirements must be met to be issued a permit tag:

- Negative Coggins paperwork for each horse registered**
- Accept and sign arena rules agreement & waivers
- Display bridle tag while on property
- Wear ASTM-SEI certified riding helmet while on a horse
- Submit permit fee for public open arena usage.



**According to Section 7 of the Illinois EIA Control Act, The Illinois Department of Agriculture requires proof of negative *Coggins* test dated within one year for all participants.

Arena Policy

To make an enjoyable, safe riding environment for all who come to rent the facility or ride on a public open arena permit, please observe the following guidelines:

- Lunge horses only if there are no other horses in the indoor arena
- Pass left shoulder to left shoulder
- Slower/walking or cooling horses out on inner track
- Disruptive horses, bucking horses, run-away or other behaviors that may pose a risk to other participants and themselves will be asked to dismount or leave the indoor to resolve the matter before re-entering the indoor arena
- Call out to other riders if you will circle, use long diagonal, short diagonal, etc.
